RULE 8 - MEMBERSHIP

Candidates for admission to the club shall be elected by The Committee. **A candidate must be proposed and seconded by two members of the club, both of whom must be personally acquainted with and responsible for the eligibility of the candidate**, and any dues incurred in connection with the Club prior to payment of Entrance Fees and Subscription, except that new residents in the Island may be proposed by the committee providing that satisfactory references have been obtained from any previous club or other source. **No candidate may be proposed by a member whose membership is of less than twelve month's duration.** Former members wishing to rejoin the Club and Junior Members wishing to become full members, must be proposed and seconded in accordance with the foregoing rule.

The name and address of the candidate and names of the proposer and seconder shall be posted in the clubhouse at least fourteen days before the day of election, any member objecting to a candidate must notify the Secretary within this period. Any candidate whose name is so posted shall have the privileges of Members, but should the candidature not be completed by payment of subscription, etc. he or she will then become liable for any dues formerly incurred. **Two adverse votes by Members of The Committee shall be sufficient to reject a proposed new member.**

The Club shall be divided into a Gentlemens' Section and a Ladies Section subject to the limitations imposed upon non playing members by rule 7.
